BC Hydro's and FortisBC's reports are biased and are an attempt to cover up the truth about the adverse impacts of the two-tier rates. Neither report directly answers the questions posed by the Minister. BC Hydro's conclusion that there is "no evidence" of cross-subsidization nor high bill impacts is unsupported by any analysis and, in fact, is directly contradicted by the many letters of comment that have been submitted to these proceedings. Both reports are unacceptable as a response to the Minister. Nick Marty is an outside expert on these matters and he has sent you a clear and concise report that honestly appraises the impacts of two-tier rates on customers like us. I strongly submit that Nick Marty's report should be the basis of your response to the Minister."

In the rural area where we live, we do not have access to natural gas for the purpose of heating our home. The two tier power billing system that applies to this area has become prohibitively expensive for heating and has pushed us to burning wood fuel as our primary heating solution. We are now also sourcing coal for the same purpose of heating.

It is unfortunate that due to the high cost of electricity in this area, it has forced many to now move backward on the environment and revert to solid fuel burning in order to heat their homes.
