 - oral hearing; or
 - some combination of processes, as appropriate;
2. Proposed intervener evidence, if any, and its nature; and
3. Other matters that will assist in the efficient and effective review of the Application.

Appendix A to this letter provides possible regulatory review process options and timelines which are intended to be helpful for parties to consider in advance of making submissions to the Panel. Please note that the content in Appendix A is not intended in any way to constrain participants' views with respect to the nature of the regulatory process or the dates of the regulatory timetable.

Interveners may provide written submissions if they are unable to attend the Procedural Conference. **Written submissions, if any, should be filed electronically via the Commission's eFiling system on or before noon on Monday, December 4, 2017, and emailed to ICBC at Regaffairs@icbc.com.**

The Panel will consider the submissions received when establishing further process in the regulatory timetable.
