The inquiry proposed in Order G-10-18 has the potential to directly affect how ChargePoint participates in the competitive electric vehicle charging market in BC, and likewise our customers' ability to own and operate charging stations and charge drivers fees. ChargePoint is therefore intervening in this process to ensure electric

vehicle charging grows and remains competitive, to provide its perspective on the role of utilities concerning electric vehicle charging stations, and to address the provision of electric vehicle charging services generally.

The outcomes of the Inquiry may influence the competitive nature of the electric vehicle charging market, and accordingly directly affect ChargePoint's business in BC. ChargePoint is the leading electric vehicle (EV) charging network in the world. More than 45,000 independently owned public and semi-public charging locations, and 7,000 customers, use ChargePoint infrastructure and software in Canada, the United States and Europe. These locations span homes, workplaces, public lots, and highways, and include over 600 public stations in BC. ChargePoint also has significant experience in the electric vehicle charging industry, and its participation would assist the Commission. ChargePoint drivers have completed more than 33 million charging sessions, saving upwards of 33 million gallons of gasoline and driving more than 803 million gas-free miles.
