To Kinder Morgan: I respectfully request you supply to the interveners and board of BCUC the following

- 1) The register of share holders of Kinder Morgan including but not limited to identification of which shares are fully paid up,and which are only subscribed to or subject to loan or collateral gaurantees,or security against debt(s),past ,present,or subject to civil litigation'criminal compensation orders existing or likely to result in an effect upon the Corporation for conduct of it's directors or agents.
- 2) A personal disclosure of the directors of all related or subordinate holdings of Kinder Morgan and a summary of Canadian unit holders(and register of their dirrectors for corporate share holders and dirrectors)
- 3)A declaration of involvement with the power project known in BC as the SE2 project at Sumas Washington

To Terasen:

- 1) all related documents to right of ways,easements and land use restrictions granted Terasen.A comprehensive map visually detailing the arterial infrastructure of said lands.,a total of land area involved stated in acres,and a detailed curent survey of all such lands including environmental impact reports related to activation of dormant titles,and projectable renovations to existing "in use sites"
- 2) Letter of assent from the Governor General of Canada permitting the entering into a negotiation of transfer of soverienng teritorial land right.
- 3) all documents detailing the granting of transfer from public ownership of the assets of Terasen by the Government of BC,and the requisite Federal legislation to permit such a transfer.
