RE: NOTICE OF APPLICATION AND PUBLIC HEARING - PROVINCE 24JAN2010, A24

In order to respond to your deadline of January 28, 2010, pursuant to your Notice described in the Province publication of January 24, 2010 on page A24, we are acting for the Sovereign Originals for the Sovereign Squamish Government (SSG) and act as Third Party Intervenors to confirm that no proper consultation took place with the hereditary leadership for the Squamish lands. It appears that 'invisible' technologies are producing private corporate contracts between INAC, BC Government and its agencies in a conspiracy to act with mens rea, in fraud with national corporate interests by taking, theft pursuant to the Criminal Code Act and producing energy resources by Trespass on Squamish lands.

We hereby reserve the right to inform all parties to this matter, that the contracts created for \$27.4M + \$5M + \$3.1M CAD for Growth Capital, Sustaining Capital and BCTC Capital must be shared in a tax free revenue profit to the Sovereign Squamish Government. Failing to provide recognition or revenue sharing of these 'capital contracts' to Siyam Kiapilanoq/CAPILANO and the Squamish true original sovereigns, will deem our collective right to report the debt of the security to the Bonds of the Named Chairman, Executive Committee members and Board of Directors to the CFR, the NWO and the World Bank in order to lay first lien claim against the named Debtors without further Notice.

The contract issued against the named pending Individual and Corporate Debtors is calculated as follows: Theft, Fraud and Trespass = 3 x \$9T (Nine Trillion hard lawful currency) \$27T debt multiplied x each Corporate and Individual Debtor. A copy of this

Notice will be posted on our website under Notices with our rights to inform the investors. Copies will be forwarded to our Independent Private media, producers and directors, supporters and to the UNHRC, presiding UN Secretary General, RCMP, FBI, CIA, INTERPOL, Securities Commissioner and a copy of this Notice will be forwarded by regular mail along with a Squamish Sovereign Government land claim.

We require a written response within 7 days from the date of receipt of this email, to confirm that these contracts have nothing to do with the natural resources located on Squamish Lands. Failure to comply within this stipulated time frame will result in automatic issued contract of debt that is secured by a lien to protect the value of the interest and Credit the SSG with no further Notice.
