BCUC INQUIRY INTO THE REGULATION OF SAFETY EXHIBIT A-6

To: Registered Parties

Re: British Columbia Utilities Commission – Inquiry into the Regulation of Safety – Project No. 1599100 – Further Regulatory Timetable

On January 27, 2021, the British Columbia Utilities Commission (BCUC) held a procedural conference for the BCUC's Inquiry into the Regulation of Safety (Inquiry) in which interveners were invited to comment on the BCUC's proposed approach to the Inquiry.

In consideration of intervener submissions, the BCUC has determined that the Inquiry will be conducted in two stages and established a further regulatory timetable, attached as Appendix A to Order G-34-21, dated January 29, 2021.

The regulatory timetable includes two options for further process: "With Intervener evidence" and "Without Intervener evidence". The first option is in the event that Interveners wish to file evidence addressing Stage 1 of the Inquiry. This process allows for BCUC and Intervener information requests (IRs) on the evidence filed, followed by Intervener final and reply arguments. The second option is in the event that no Intervener evidence is filed, in which case, the regulatory timetable will proceed directly to final and reply arguments. The BCUC will update participants in the Inquiry shortly after September 16, 2021 on the process that will be followed.

The BCUC notes that Table 1 provided in Exhibit A-4, which outlined the Proposed Process for Stage 1, referenced "Intervener Submissions" throughout. For clarity, the BCUC has updated the terminology used in the regulatory timetable, attached as Appendix A to Order G-34-21, to refer to "Intervener evidence" and "argument" explicitly.

ORDER

WHEREAS:

- A. By Order G-241-20, dated September 23, 2020, the British Columbia Utilities Commission (BCUC) established an inquiry to examine the role of the BCUC in the regulation of safety (Inquiry) and established a regulatory timetable, which included written submissions and letters of comment, with further process to be determined;
- B. On November 12, 2020, the BCUC received intervener written submissions and letters of comment, addressing the BCUC's jurisdiction with respect to the regulation of safety, legislative gaps or overlaps, and whether a workshop in support of the Inquiry would be beneficial;
- C. By letter dated December 17, 2020, the BCUC requested submissions from stakeholders and participants on whether the scope of the Inquiry should include the regulation of safety for the Insurance Corporation of British Columbia (ICBC);
- D. By Order G-342-20, dated December 18, 2020, the BCUC established a further regulatory timetable for the Inquiry, which included the proposed scope for the Inquiry and a web-based procedural conference;
- E. The procedural conference took place on January 27, 2021. The following interveners attended the procedural conference and made submissions: British Columbia Hydro and Power Authority; British Columbia Old Age Pensioners' Organization *et. al.*; Commercial Energy Consumers Association of BC; Corix Multi-Utility Services Inc.; Don Flintoff; FortisBC Energy Inc.; FortisBC Inc.; Kyuquot Power Ltd.; Pacific Northern Gas Ltd.; Pacific Northern Gas (N.E.) Ltd.; River District Energy; Surplus Energy Match; TE Burns Engineering Ltd. (Ka:yu:'k't'h' / Che:k'tles7et'h' First Nations); and Technical Safety BC;
- F. The BCUC has considered the submissions made by interveners at the procedural conference and determines that the Inquiry shall be conducted in two stages. Stage 1 will establish a general framework of

key principles for the BCUC's regulation of safety. Stage 2 will explore the application of a framework to the BCUC's regulation of public utilities and how the BCUC will implement its mandate with regards to safety; and

G. The BCUC finds that establishing a further regulatory timetable is warranted.

NOW THEREFORE the BCUC establishes the regulatory timetable, as set out in Appendix A to this order.
